- Photos must be recent and taken in Clarendon County
- Photos must showcase agriculture or conservation and possess Farm-City Spirit.
- Only one photo per Affiliate Member may be entered
- All photos must be submitted in digital format. Photos may be e-mailed to casey.blackmon@sc.nacdnet.net or brought to the district office.
- Framed or matted photos will not be accepted.
- Photos must be submitted with the entry paperwork completely filled out.
- Photos become the property of the Clarendon Soil & Water Conservation District, and they reserve the right to use all photographs in their publications, on their web site, and for conservation promotion purposes.
- The entries must be received by 4:30 p.m. on Friday, November 12, 2010.

Judging/Awards:

- Photos will be judged by the Farm-City Contest Committee based on creativity, originality, and farm-city spirit.
- The top five photos will be placed on display at the annual Farm City Luncheon on November 22, 2010 where guests will be able to vote for their favorite photo.
